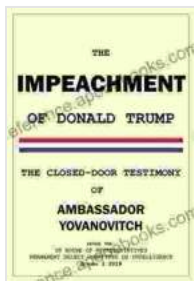


# The Closed Door Yovanovitch Testimony: A Bombshell in the Impeachment Inquiry

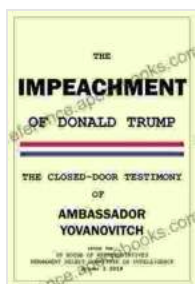
